The December 16 deadline is fast approaching. Many people have decided to intervene in the Presidential Permit process at the Dept. of Energy. Note that both the Dept of Energy and the State Department must both approve the permit. Most likely the final ok will come from undersecretaries in each of those departments. If you have not done so, take a few minutes to write a comment and express your concerns. If you need information on where to send it contact info.

## **Town Warrant Petitions**

It's probably been a bit confusing with all the petitions going around but it's very important that each town have a petition on their town's warrant for next town meeting. We are hoping that every town along the route will agree with the petition that they do not want the power line in their town. There has been a bit of confusion between petitions but be sure that your town is covered. There is a draft petition which you can send for. We suggest you contact your town office to check on last date to bring it in (this seems to vary from January 1 to January 11<sup>th</sup>) and the actual number of **registered voters** from your town are needed to sign. Ten signatures is the usual number but it will be more powerful if you can get 25. Contact info if you have any questions.

**The Town of Lancaster will finally have an information meeting.** Since PSNH didn't schedule one there residents from the Lancaster area have arranged with the town selectmen to host an info meeting on Thursday, January 6<sup>th</sup> starting at 6. People from surrounding towns will be welcome to attend as well. Speakers on the path of the line in that area, health, legal and other issues will be discussed. People are invited to come with questions. So spread the word.

Good News from the Conservation Law Foundation, which has been working in our region since 1966 to support healthy communities and a clean natural environment. They will be adding an attorney to their Concord office to assess the impact of the Northern Pass project on New Hampshire. Their case
