## TOWN MEETING AND PETITIONS ON WARRANT – NOWS THE TIME TO ACT AND INFORM YOUR FELLOW TOWN RESIDENTS!

Over 19 towns in NH have petitions on their warrant to be voted on at town meeting this year. It's important in those towns that people begin to discuss the issues with their neighbors and fellow town residents. Some towns may have the petition on the ballot while others will be able to vote on it during the town meeting. Put up signs, hand out buttons, knock on doors, and write letters to the editor to your local newspaper if you can. Many people are still unaware of the real issues and impact of Northern Pass. Towns that we know (although there

may be some errors) about that have accepted a petition are Colebrook, Sugar Hill, Columbia, Lancaster, Easton, Dalton, Bethlehem, Clarksville, Whitefield, Stewartstown, Northumberland, North Stratford, Campton, Plymouth, Thornton, Holderness, Rumney, Woodstock, Lincoln, Ashland and Pembroke.

# EIS SCOPING HEARINGS (Many of you know this but we have so many new email list members it's important to share the information again.)

Be sure to register to comment on the Environmental Impact Study (EIS) scoping hearings coming up in March. This will be your opportunity to reflect on and submit the issue(s) that you are concerned about. An EIS web site at <a href="http://www.northernpasseis.us/index.asp">http://www.northernpasseis.us/index.asp</a> has been set up on the Northern Pass site where you can find information on the Process, How to Get Involved, Comment Section, and a Document Library where you will find a listing of people who applied as interveners in the Presidential Permit Process, made comments, scoping comments, who opposed the hiring of Normandeau Associates to do the studies and other documents. Over time, you will find other documents here so be sure to bookmark the site.

Since Northern Pass has proposed a large number of routes, some preferred and some alternate it's important to be aware that this is a typical "divide and conquer" strategy that is used for such projects which lends itself to accusations of NIMBY. However, you do want to have on record an historical property or environmental issue that is significant.

So here is a list of some of the impacts you might address:

Impacts will be analyzed across a number of resource areas, including:

- Air quality (including climate change and greenhouse gas emissions)
- Water resources and drainage
- Geography, geology, and soils
- Land use
- Threatened and endangered species, special status species, and related sensitive resources
- Airspace utilization
- · Public health and safety
- Noise
- Natural hazards
- Hazardous materials
- Accidents and intentional destructive acts
- Cultural and historical resources
- Recreational resources
- Visual resources
- Socioeconomic impacts, community services and infrastructure
- Environmental justice considerations (disproportionately high and adverse impacts to minority and low income populations)
- Cumulative impacts (past, present, and reasonably foreseeable future actions)

• Irreversible and irretrievable commitments of resources
