HAVERHILL, N.H. — At the request of New Hampshire Sen. Kelly Ayotte, the U.S. Department of Energy is hosting an additional hearing on a proposed power project in Haverhill.

A federal permit is required for the Northern Pass project, which would provide hydroelectric power from Canada to New England. In addition to a hearing scheduled for March 20 in Haverhill, there will be six other public hearings around the state the previous week.

Ayotte says many North Country residents expressed concerns about the project when she visited the region last week

Many suffered from hypothermia and carbon monoxide poisoning. Heavy ice sheets toppled huge power pylons and in just six days an electrical system that took decades to create was razed.

Wentworth selectmen vote to oppose Northern Pass, as reported in their letter to NH State Senator Jeanie Forester:

### Good morning Jeanie,

Wentworth's Board of Selectmen had a public discussion last night on the subject of the Northern Pass project. There were many good points made by those in attendance, and at the conclusion the Board of Selectmen voted without dissent to officially oppose this project as currently constituted. An official correspondence is being prepared to send to your office and those of our State Representatives, Governor Lynch and Councilor Burton.

At the end of the meeting I challenged everyone to do more than just protest energy and distribution projects. We all have the responsibility to improve the cost and availability of energy with practical and cost effective generation and distribution solutions, combined with good stewardship of our existing resources. Personal commitment to aggressive energy conservation in our homes and businesses is a good start. I thought it was important to discuss this as there were some in attendance that also actively opposed the Groton wind farm project.

They agreed that active participation in solutions to grow jobs and the economy are all our responsibilities.
